Thank you for your interest in Galena Country Fair!

If you were accepted into the 2020 fair, we thank you for your patience and understanding as we navigated through the unique aspects of last year.

We have decided to start accepting applications for the 2021 event and will proceed with the juried vendor selection. The 2020 vendors will not be automatically rolled over to the 2021 event. All 2020 vendor checks were returned. We encourage all interested vendors to fill out the 2021 vendor application and complete the steps to be considered for the 2021 event.

This year, the two-day event will be held on October 9-10, 2021, in historic Grant Park overlooking Galena, Illinois. We hope to plan it similar to the past with more than 150 vendors selling a variety of high-quality, original handmade arts, craft, and fine arts; food booths; family fun; live entertainment; children's games; a silent auction; and raffle.

Early Bird Shoppers: Many shoppers arrive by 8 a.m. both days.  
*We recommend vendors are open and ready for business by 8 a.m.*

**When filling out your application, please print.** If we cannot read your handwriting, your data may get entered incorrectly. This will impact the way your business name, vendor name, and product information are displayed in promotional materials and on your booth sign.

We also ask that you provide your best email address on the application. Please share with us the email address that you check regularly. All vendor correspondence will be sent via email this year. We definitely want all Galena Country Fair information to reach you! Please add @GalenaCountryFair.com to your Whitelist, which may also be called the Approved or Safe Sender List. Adding @GalenaCountryFair to your Whitelist is an important step that improves the chances of our emails reaching your inbox instead of your spam or junk folder.

### EVENT INFORMATION & VENDOR GUIDELINES – page one

Galena Country Fair is held at Grant Park, located at 625 Park Avenue in Galena, Illinois, on Saturday, October 9, 2021, from 10 a.m.-5 p.m. and Sunday, October 10, 2021, from 10 a.m.-4 p.m.

Galena Country Fair is an outdoor, rain or shine event. There is no rain date for this event.

**BOOTHS:** Vendor booth spaces are 10' deep x 12' wide. All spaces are marked. One space is allowed per vendor. Only one vendor is allowed per booth. Booth assignments are allocated by the committee. Location requests are not guaranteed. If your booth or product display is in another vendor's booth space and/or the walkway you will be asked to move your booth and/or product display within the boundaries of your marked vendor space.

Each vendor supplies their own tent and display materials.

No generators are allowed. Electricity is not available for vendors.

#### **COSTS / FEES:**

**BOOTH FEE:** A \$225.00 check or money order is due with the Vendor Application.

**ITINERANT MERCHANT LICENSE:** Any person engaged temporarily in the sale of goods for fewer than five days at a single location in the City of Galena must apply for an Itinerant Merchant License. To be considered for a vendor space, every Galena Country Fair Application must include a City of Galena Itinerant Merchant Application (filled out with required signature) and a \$25.00 check or money order payable to the City of Galena. If you are accepted into the fair, your Itinerant Merchant Application will be forwarded to the City of Galena. Upon approval, the City of Galena will give your license to Galena Country Fair. Vendors will receive their Itinerant Merchant License upon delivering their Silent Auction Item to the Information Booth located near the Gazebo.

**SILENT AUCTION ITEM:** Each artist/craftsperson must donate One item worth a minimum of \$20.00 from their booth the weekend of the fair. The item(s) will be used for the Silent Auction to benefit charitable organizations in Galena and Jo Daviess County. Vendors should turn in their item(s) at Vendor Registration located at the Information Tent near the Gazebo. *Silent auction item(s) must be turned in to receive Itinerant Merchant License.*

**PROCEEDS FROM SALES / TAXES:** Vendors will receive all proceeds from sales at their booth. All out-of-state or non-licensed Illinois businesses are required to submit a Special Event Tax Collection Report and Payment Coupon (Form IDOR 6-SETR) within ten days of the close of Galena Country Fair. This form will be included in the packets given to vendors the weekend of the fair.

**VENDOR SELECTION:** Only vendors selling handmade, original items will be considered for Galena Country Fair. Vendors will be selected by a jury process in the following categories:

- Country Crafts**      small wood items, baskets, needlework, dried flowers, wreaths, dolls, stuffed animals, quilts, etc.
- Crafts**                stained glass, weaving, woodworking, metalworking, clothing, pottery, jewelry, etc.
- Fine Arts**             sculpture, oils, acrylics, batik, watercolors, photography, pen and ink prints, lithographs, etc.
- Farmer's Market**    honey, maple syrup, produce, etc.

**NOTICE OF ACCEPTANCE:** The judges will select vendors during the first few weeks of April. If accepted, vendors will be notified by April 30, 2020. Vendors' checks will be cashed in May. Photos will be returned in vendor packets the weekend of Galena Country Fair. Vendors not accepted will have their checks and photos returned.

**CANCELLATION:** If you must cancel your booth, please call 815-777-0817 immediately. If your cancellation is received after August 31, 2021, your booth entry fee (\$225.00) and Itinerant Merchant License fee (\$25.00) will not be refunded.

**JUDGING / PRIZES:** Cash prizes are awarded in each juried category (Country Crafts, Crafts and Fine Arts) plus a Judge's Choice category. Judge's Choice winners are selected from all entries. *1<sup>st</sup> – \$100.00; 2<sup>nd</sup> – \$75.00; 3<sup>rd</sup> – \$50.00*

**PACKET PICK UP:** Vendor packets are available at Vendor Registration located at the Information Tent near the Gazebo at the following times: Friday, October 8, 2021, from 7 a.m.-7 p.m. and Saturday, October 9, 2020, from 8-10 a.m.

**SET UP:** It is recommended that vendors set up on Friday from 8 a.m.-7 p.m. to alleviate Saturday morning congestion.

**LOAD IN / OUT:** No vendor may close before the official closing time of the event, which is 4:00 p.m. on Sunday. Vendors breaking down early may not be accepted to future Galena Country Fair events.

The loading/unloading zone along Park Avenue is reserved for artists and craftspeople only. Please obey all signs as posted and move your vehicle as soon as it is loaded/unloaded as a courtesy to other vendors who are waiting.

No vehicles are allowed in Grant Park. Garden tractors with carts will be available to help vendors haul for a donation. The donation amount is decided between the driver and the vendor. *Load-in/load-out assistance is not organized by Galena Country Fair.*

**PARKING:** One parking permit is provided in each vendor packet. Vendors may park one vehicle/trailer for free in the City of Galena parking lot located near the Old Train Depot (101 Bouthillier St.) as long as the parking permit is properly displayed in the vehicle. By authority of the City of Galena Police Department there is no vendor parking on Park Avenue until Thursday at 12 noon.

There will be no permanent parking of vendor vehicles or trailers on Johnson Street. Please obey all parking signs and parking restrictions as posted.

**SECURITY:** Security is provided from Friday at 7:00 p.m. until Saturday at 7:00 a.m. and from Saturday at 7:00 p.m. until Sunday at 7:00 a.m. *Neither the security provider nor the sponsor of the fair are responsible for items lost, stolen or damaged.*

**SMOKING:** There is no smoking in Grant Park during Galena Country Fair.

**DOGS:** Please leave your dogs and pets at home for this event. Only individually-trained Service Dogs that are trained to work or perform tasks may be in Grant Park during this event. Emotional support animals are not recognized as service dogs by the Americans with Disabilities Act (ADA). We appreciate your cooperation.

**LODGING:** Galena Country Fair is an extremely busy weekend. Area lodging fills rapidly. We recommend reviewing information on the VisitGalena.org website or searching Airbnb, HomeAway and VRBO. Call our tourism office at 815-776-9200. We would love to host all fair vendors in our local lodging; however, it is sometimes difficult to find a place to stay on fair weekend. More lodging is available 15 miles west of Galena in Dubuque, IA.

- \$25.00 Itinerant Merchant License fee in the form of a check or money order payable to the City of Galena.
- A large, legal-size self-addressed stamped envelope. (Large enough for your photos to fit into.)

- Provide your best email address. The one you check regularly.
- Add @GalenaCountryFair to your whitelist, approved, and/or safe sender list.

**VENDOR RESPONSIBILITY:** Vendor is fully responsible for any loss or damage to his or her property by theft, fire or casualty. Jo Daviess County Country Fair Charities, Inc. (Galena Country Fair) expressly disclaims any responsibility for same. Each vendor is responsible for the conduct of his or her representatives and must not detract from the image or welfare of the show.

## Itinerant Merchants & Itinerant Vendor Application

**Itinerant Merchant:** Any person who is engaged temporarily in the sale of goods, wares or merchandise, either in new or used, who, for the purpose of conduction such business, occupies or uses any convention center or any other location within the municipal limits for periods of fewer than five days at a single location to display or sell such goods. Exceptions to this are individuals conducting not more than two garage sales per year on private residential property.

**Itinerant Vendor:** Any person who transports tangible personal property for display or sale at a convention center or any other location within the municipal limits who does not maintain an established office, distribution house, sales house, warehouse, service center or residence from which the business is conducted.

### Please note:

1. Permit can only be issued in connection with sales offered as a part of a dully licensed fair, festival, or flea market.
2. The agent of the duly licensed fair, festival, or flea market event shall provide the City Clerk with the completed applications and forms of each vendor which participates in the event at least ten (10) days prior to said event. License fee shall be paid by the itinerant vendor or itinerant merchant at the time of the application. Applications without all required information will not be processed.
3. If the application is a partnership, each partner, principal, or member thereof both individuals must complete the application. If the application is a corporation, the application shall contain the information for principal officer and the registered agent thereof. If more room is needed, use separate sheet of the reverse side of this application.
4. The fee for an Itinerant Merchant or Vendor License shall be twenty-five dollars (\$25.00). A license shall not be valid for more than seventy-two (72) hours.
5. **Out-of-State Businesses or Non-Licensed Illinois Business:** All Out-of-State or Non-Licensed Illinois Businesses will be required to submit a Special Event Tax Collection Report and Payment Coupon (Form IDOR-6-SETR) within ten (10) days of the close of the event to the Illinois Department of Revenue, Collection Bureau, PO Box 19035, Springfield, IL 62794-9035. **This form will be provided to you by your event sponsor.** Any questions with regard to this form or submission of the tax should be directed to [Rev.SpecialEvents@Illinois.gov](mailto:Rev.SpecialEvents@Illinois.gov) or by calling 1.847.294.4475.
6. **Illinois Licensed Business:** If you are an Illinois licensed business and have a current Illinois Business Tax Number and have added Galena, Illinois as one of your listed changing locations, you are not required to submit the IDOR-6-SETR form. If you would like to add Galena as a changing location, please contact the Special Events Coordinator at [Rev.SpecialEvents@Illinois.gov](mailto:Rev.SpecialEvents@Illinois.gov) or by calling 1.847.294.4475 and they will assist you in adding this to your registration at no charge to you.

7. Each vendor shall post in a conspicuous location at the vendor's location booth the license issued by the City of Galena for said vendor to participate in the duly licensed fair, festival, or flea market. This license shall be posted throughout the duration of the event for which the license was obtained.
